- Not allowing entrance to any unauthorised person
- Ensuring that children and young people do not leave the building on their own
- Not allowing children and young people to leave the building unchecked
- Not allowing a young person to leave with someone unknown to the leader, unless prior notice and permission has been granted by the parent/guardian
